- 3) The purchaser(s) waives any and all rights he/she/they might have under Louisiana law to seek a rescission of the sale or a reduction of the purchase price.
- 4) Purchaser(s) hereby give(s) permission to _____ to process my/our transaction with the Department of Motor Vehicles.

- 6) I/We, purchaser(s), appoint _____ as my/our attorney-in-fact to sign all documents necessary to make corrections to clerical or typographical errors; to sign forms omitted in error which are required for the sale of the above mentioned vehicle; to obtain a duplicate title within the 60 day grace period; and the right to apply for, receive, and assign any refund resulting from erroneous processing of the title transfer related to the aforementioned vehicle. This power of attorney shall remain in effect for a period of one year from the date of execution.
